Current year savings reflect a year on year decrease in expenditure on one off non recurrent items (£1,758). Additionally, there were no major repairs to play area equipment (2014/15 £1,125).

In 2014/15 there was significant expenditure on non recurrent one off items. (Village road fence repairs (£343), Christmas lights maintenance (£610), purchase of computer equipment for the Clerk (£498) and Cleaning of the war memorial (£1,643). In 2015/16 the one off non recurrent expenses were (Pond clearance £300, New gate following vandalism £274, chainsaw refresher course £264).

2015/16 saw new costs of £1,067 for emptying of dog bins.
