Box 2

The precept had not been raised for a number of years and with the rising costs of maintaining the Parish owned land which includes a playground with old equipment Council agreed that an increase was required to ensure it could fulfil its responsibilities to maintain these areas to the expectations of the residents.

Box 6

- There were 3 invoices for dog bin emptying included in the financial year 2016-17. One was received late and was included but referred to 2015-16. £356 overspend
- Tree work on Tower Rd was more than budgeted. The budget was £200, the invoice was £620 therefore an over spend of £420.
- A speed tube assessment was undertaken that had not been budgeted for but was taken from a Bucks CC road safety grant given by the BCC local Councillor. £620 cost
- A sign was purchased for the displaying by the road at the village pond to alert drivers to wildfowl crossing at a cost of £222.

<u>Box 7</u>

- Reserves include £1600 from a grant from BCC for road safety projects
- Reserves include £1000 from the 2016-17 budget for a children's activity trail project at the Jack Adams Field which will be added to each year until there is sufficient funding.
- Reserves include £700 set aside for future war memorial upkeep.

<u>Box 9</u>

- An old see saw had been disposed of due to rot value £1614 (original cost)
- An additional jubilee bench was found when the full asset check was completed that had not been included when the bench was purchased valued at £700.
- A sign was added on 2.2.17 for placing at road by the pond warning of wildfowl crossing cost £222
