Other matters not affecting our opinion which we draw to the attention of the smaller authority:

Fixed assets at Box 9 for March 2016 was initially incorrect because the entry was not adjusted for asset discoveries made during the following year. The 2015/16 figures should have been restated to ensure both figures were consistent. In future, the Council should ensure the annual return is accurate and complete.
